Participant Consent Form

I understand that I have the following rights concerning Girlfridayz online workshop The Cat Got The Cream.

1. You have the right to withhold or withdraw consent at any time without affecting your rights. You can cancel any order before any work commencing within the first two weeks of the order being accepted and work has not begun.
2. The weekly and monthly support offered by The Cat Got The Cream online workshop is subject to this condition. You are allowed to cancel meetings arranged for any reason; however, you need to inform us 24 hours before the cancellation occurs.
3. You can cancel any collaborative work as per point 2. If you don't attend the workshop support provision on three occasions, we will deem that you are no longer able to participate in the growth accelerator online support provision for your business, no refund will be issued because you would have fully participated in the support provision before your cancellation date.
4. If work has begun on your project and you wish to cancel a cancellation fee will apply which is 50% of the total price which equates to the value of your payment term remaining balance. If your cancellation takes place within the 15 months of the monthly service provision, or if we nearly completed your business support provision and you cancel one month before the termination of the workshop support a 100% cancellation fees apply based on your payment term remaining balance.
5. I understand that I need to inform Girlfridayz that I would like to invite in meeting arrange any third party before attending the meeting and that express consent needs to be sought in writing in conjunction with the Data Protection Act 1998 and the new European Union Privacy Regulation (GDPR) which came into force 25/05/18.

8. The participant of The Cat Got The Cream online workshop needs to agree to be recorded for the service provision as we are using Zoom, and What's App group meeting facilities for the first three months of the Incubation Pathway weekly support and the 15-month Mentoring Support.

11. You are not permitted to record any meeting without Girlfridayz's prior consent. We require your consent in writing per the Data Protection Act 1998 and the new GDPR 2018 for points 7,8,9 and 10.
12. Girlfridayz will only disclose information held in your file with us with you if requested preferably in writing in conjunction with the Data Protection Act and the GDPR, but we will accept disclosure consent requests over the phone on occasion.
13. You can share your information with any third party if you wish to do so. However, if any third parties choose to disclose your information discussed with us — contact us via any means about your information held with us to discuss it with us, if the information disclosed is maliciously used and damages our reputation you will be prosecuted. We at Girlfridayz will not discuss your information with any third parties without your express consent preferably in writing but we will accept disclosure consent over the phone on occasion.
14. You are not permitted to share information provided by us about our meeting either online or face to face, email sent, or recording permitted on any social media platform or the media without our express consent because our information is sensitive or could create a conflict of interest punishable by UK law and we require the minutes of the meeting to be sent to us. This term also applies to any of your associates, peers, family members, friends, staff members or any other third parties involved in our meeting or not involved in our meeting. If you have



chosen to disclose your information to anyone, we are not liable if the information conveyed is damaging to you.

- 15. Should you or your third parties breach term 14 of this consent form you will be made liable if the information conveyed is damaging to our reputation and business.
- 16.
