- 2. - 7. You can share your information with any third party if you wish to do so. However, if any third parties you choose to disclose your information discussed with us contact us via any means with regard to your information held with us to discuss it with us. We at Girlfridayz will not discuss your information with any third parties without your express consent preferably in writing but we will accept disclosure consent over the phone on occasion.
- 8. You are not permitted to share information provided by us about our meeting either online or face to face, email sent, or recording permitted on any social media platform or the media without our express consent because our information are sensitive or could create a conflict of interest punishable by UK law and we require the minutes of the meeting to be sent to us. This term also applies to any of your associates, peers, family member, friends, staff members or any other third parties involved in our meeting or not involved in our meeting. If you have chosen to disclose your information willing with anyone, we are not liable if the information conveys is damaging to you.
